Reception of Visitors/Public Comment:

Mr. DJ Lorton and Mrs. Heidi Doyle were in attendance to give the Board information about the state convention and their new community food pantry. The FFA members have stated a desire to make it to the stage next year at the convention, so they are working and planning extra events to

help achieve that goal. Several members placed in the competitions at the convention. The Dairy Foods, Forestry Contest are events still to come. They are currently holding a "Shabang" every month to get the members excited, and have a "discovery" program at the Elementary with 16 students involved from the school. They thanked the school board for allowing them to start the 8th grade program. They are educating that the FFA is not just an Agriculture related group, but that there are many facets to the program. Mrs. Doyle stated the current FFA are a very good group to work with this year. They both spoke about the community food bank program. Mr. Lorton stated "it's not about what you have to give, but more of the idea of how you can increase for others". They make grocery bags for needy families, and are in need of food donations.

Ms. Tara Adams and Ms. Melissa Keil were in attendance to present a display made by the students that correlates with the new reading curriculum. The students had made models of the town of Hardin after they took a field trip to several of the town businesses. Ms. Adams and Ms. Keil stated the businesses downtown were very generous with the kids during their visits. The classes were focusing on being a good community members. They stated that the new curriculum has built collaboration between the classes as well, since they are all studying the same material, just at different levels over the classes. The Board thanked them for their attendance and for their presentation.

Mr. Zach Smith informed the Board that the co-op for the Track with Pleasant Hill was up for renewal. He stated there are over 16 kids involved in the program and that Calhoun currently has more involvement than Pleasant Hill. The season will begin shortly after basketball, in March/April. Lon Grandia also stated support for the track program.

Mrs. Burris and Mr. Dylan Ringhausen presented information to the Board concerning the School Improvement Plan for the year. There was a handout given to the Board members covering information from credits needed for graduation, electives, testing, growth charting, Teacher and Family involvement.

Discussion:

Dr. Sievers informed the Board that the Consultation Committee would meet December 6 at 4:15 with the CEA. The concession stand conversations are still taking place. Sue Hillen has been the only one to show an interest in heading up the stand. There is still communication with Warrior Pride to set up and provide the workers. Currently Kathy and Cheri are keeping the stands staffed. Every organization has mentioned an all or nothing approach to taking the stands over. The Board members stated the goal needs to be to get the Principals away from running the stands, to dedicate

their time to more administrative duties. Dr. Sievers stated that there are currently 4 positions on the School Board that are up for election, and that she is getting the word out for good quality candidates. She has also been hearing about solar energy from a couple of conferences she has attended. The school has the land to implement solar panel installation, she is asking the Board if she should pursue gathering information. She also did a comparison of the area schools academic progress, Calhoun is doing very well. The Veterans Day Program held at the High School was reported as "Phenomenal". There was a good attendance, and is a very impactful program. The Risk Management Plan was presented to the Board for approval. She also gave an update for the FDA land habitat renewal that will need to be approved by the Board, and stated that the state will not allow a school but stop sign on the Kampsville route. There is a new Property Tax Relief Grant available for overtaxed districts, but is usually not given to areas unless they are over a 10% tax rate. Dr. Sievers also stated that the tax levy should be at a lessor rate this year due to the bond that was paid last year. There will be no truth in taxation hearing.
