# Reception of Visitors, Petitions and Communications:

Mr. Claude Collins was in attendance to inform the Board of the current status of the mowing. He explained that the tractor cutter had just actually broken down today, and that it would be too expensive and cumbersome – rebuilding the gear box - to make the repairs to continue to use it for mowing. He also stated that the use of the fairgrounds mowers could possibly result in repair costs for the district on equipment that wasn't district property. He asked that the Board consider the purchase of a new lawnmower. The Board thanked him for the information and for coming to the meeting.

# Discussion:

Dr. Sievers discussed the option of using an "Interrupted Day" for emergency days, which is now allowable within the guidelines of the new school funding program. She suggested that the Board allow her to still use the recent day; for a water main break; as an emergency day, which will take off one of the 5 days that are already built into the calendar.

Dr. Sievers informed the Board that Hope Klocke has turned in her intent to retire, and Mrs. Alicia Churchman has given her notice of resignation as well, for both the Bookkeeping and Treasurer positions. Dr. Sievers would like to recommend that Mr. Terry Strauch be appointed as Interim Treasurer until that position can be filled. She would also like the Board to approve the hiring of Mrs. Carol Elliott to fill in as Bookkeeper and to then train the person that will be hired as the full time replacement.
