Superintendents Report:

An amendment will be made to the budget in June.

Enrollment is at 493.

Andrea Lee and Meghan Klunk attended a MISVIC meeting. The initial change in insurance rates was predicted to be an increase of 1% with no changes in the current plan.

Governor Pritzker signed the budget. There will be an increase in the evidence based formula, transportation and special education.

Between 2019-22 a contractor for ISBE made a coding error in the implementation of the EBF formula.

Calhoun CUSD 40 will be receiving \$50,265 that is owed from the error.

House Bill 1167 has been signed into law. Summary of the law: When E-Learning days are taken, non-certified employees are to be paid, repay doc days due to COVID and any sick days used by fully vaccinated employees used for COVID will be given back.

There has been an increase in Corporate Personal Property Replacement Tax. We had budgeted for \$35,556 this year and have received \$78,289.

There will be not be an early registration this year due to switching our systems to Skyward.

Calhoun and Brussels Admin. met regarding the sports co-op. They discussed eligibility, matching up the district's early dismissal day, practice regarding snow days and tutoring.
