Congratulations to the Jr. High Volleyball team on a successful season. The girls did a great job and 8th grade ended their season with a tough loss in the regional championship to Nokomis. Big thanks to coaches Donna Hurley and Amy Hurley.

The 5/6 Boys Basketball Team finished their seasons with the 6th grade placing 1st and the 5th grade placing 2nd in the AJ Classic.

The Scholastic Bowl team is underway. The team has competed against St. John's and Carrollton. They will play St. John's again on 3/20 and Southwestern on 3/21.

The staff has been working, and with continue to work, with PD instructor Brandi Hempen.
